Minutes for the Regular Meeting of Lee Township Planning Commission Wednesday, December 15, 2021

The minutes for the regular meeting on October 19 were reviewed. Kathy moved to accept the minutes, Lawrence seconded. The minutes were accepted.

The minutes for the regular meeting on November 23 were reviewed. Lawrence moved to accept the minutes as presented, Kathy seconded the minutes and the minutes were accepted.

The commission reviewed and discussed the site plan for Tower MRL. The request was to move the existing access road to the tower at 1665 W. Isabellla Rd. six feet to the east. The request was opened to public comment. Lawrence moved to accept the site plan, Marie seconded the motion. Roll call vote: Mari, yes; Lawrence, yes; Steve, yes; Marie, yes; Kathy, yes. The site plan was approved.

Mike McPherson presented the site plan for the Dollar General to be located on the northwest corner of M-20 and 7 Mile Rd. Mike assured the commission that the Site Plan would move forward after the issues the Midland County Road Commission had raised to the build would be resolved. The commission asked for public comment. Mary moved to accept the site plan for the Dollar General, Steve seconded the motion. Kelly and Mark Osborn presented a preliminary site plan for River Forged, an assembly center to be built on the southwest corner of Chippewa River Road and M-30. motion and the motion was passed.

Mari asked the first task of Advisory Panel be the conditional rezoning for Rose Construction. Kathy moved to assign that task to the panel, Marie seconded the motion and it was passed.

New Business: Florida Garden Supply has not contacted the commission to supply a new site plan to include the building that was erected after their site plan was approved. The building was not part of the site plan and now they have moved an RV on the property that is on the set back of the lot. Kathy will compose a letter that the business is in violation of their site plan and turn it over to the zoning administrator for Lee Township.
